



## Required Courses in the Business Minors Catalog Year 2016/2017

You must complete the preparatory (“prep”) requirements with a C or better, be declared into upper division with your major and have a minimum overall GPA of 2.90 before you can declare a business minor. Remember: You need to complete the courses required for the minor in your minor catalog year (the year that you declared the minor).
